# **Local President's Report**

# **Local 323 Complement:**

The Local 323 career complement as of PP-5-16 is 654 (587 MN & 67 ND) and the MHA complement is 89 (80 MN & 9 ND). Combined Membership is 646.

#### **Local Issues:**

## Fiscal Year Change

January 1<sup>st</sup> marks the beginning of a new fiscal year and numerous tasks must be performed to ensure that the Local Union remains in compliance with the Uniform Local Union Constitution as well as with all applicable laws and regulations.

The following is an outline of the tasks performed:

- Issuance of W-2's to employees (all Representatives)
- Filing of W-2's with both States
- Filing of W-2's along with W-3 with the Social Security Administration
- Issuance of 1099's to vendors
- o Filing of 1099's along with 1096 to IRS

Following these activities we prepared for our annual audit. That was conducted on February 29<sup>th</sup> and March 1<sup>st</sup>. Local Treasurer John Frey and I completed the uploading of our LM-2 to the Department of Labor. A copy of the LM-2 was provided to the Members of the Local Executive Board via email prior to its submission. Additional filings with the IRS and the States aren't due until May 15<sup>th</sup>.

The Local Executive Board will receive the audit results from Legacy Professionals at a future meeting.



# Election of Delegates to the 2016 National Convention

The delegation for the 2016 National Postal Mail handlers National Convention has been finalized. In addition to the Local President, Vice President Kathy Schultz, ND State Executive Board Member Brock Engstrom, Saint Paul Branch President Jerry LaBarre, and Minneapolis Branch Member Elizabeth Dunning, will be representing Local 323 at the Convention this August.

## Semi Annual Meeting of the Local Unions (SAMLU)

In mid-February I was in attendance at the SAMLU which was held in New Orleans, LA. Considering that this meeting was shortly before the opening of National Negotiations, it's not surprising that there were numerous discussions concerning the National Agreement. In addition, the attendees receive the reports from the National Officers, the MHBP, the Political and Legislative Director, and the Contract Administration Department.

The final day consisted of an extensive training sessions concerning the Family and Medical Leave Act. An updated version of the FMLA manual has been sent to all Representatives on a memory stick.

# • Open Season Follow UP

For the first time in a very long time Local 323 saw an increase in the MHBP enrollment within our jurisdiction. Granted, it was a very small increase; but, an increase nonetheless. The dynamics of our market share within the FEHBP continue to improve and this may bode well for future enrollment. The possibility of Local 323 holding an independent health fair during 2016 is being considered.

Also, Local Treasurer John Frey and I completed our submission for the partial reimbursement program.

## Local 323 Dental Program

The billing of associate dues to the Postal and Federal dental affiliates has been completed. The 2016 plan was offered without a change in benefits or an increase in premiums. The plan is available to new hires upon their enrollment in the Union. I continue to serve as the plan administrator.

#### • State of Minnesota Audit

The Local Union was the subject of a random compliance audit by the State of Minnesota which was focused on our unrelated business income (primarily associate

dues). The State concluded that we owed a total of \$555.00 for tax years 2012 (\$217), 2013 (\$94), and 2014 (\$244). Payment of this assessment was recently made.

This matter continues to be under review between Local 323 and our accountants as we prepare for our upcoming tax filings in mid-May.

## **Branch Activities:**

I continue working with our Representatives throughout the Local to address issues specific to individual Branches. At the forefront of our recent activities has been the excessing of 3 Mail Handlers from the Rochester facility. Shortly after the first of the year we received a withholding notice related to this event. That notice identified a 100 mile radius in which duty assignments would be withheld for the Mail Handlers being involuntarily reassigned.

Subsequently, a dispute has ensued as to the scope of the withholding and the actual facilities which are subject to the withholding. The disagreement is the result of decisions made at the Area level; and as such, I've enlisted the aid of our Regional Director to help gain some clarification in this matter. MN State Executive Board Member Shane Ryden and I have been working on this issue at the District level.
