#### **Local President's Report**

#### **Local 323 Complement:**

The Local 323 career complement as of Pay Period 11-17 is 689 (619 MN & 70 ND) and the MHA complement is 77 (64 MN & 13 ND). Combined Membership is at 670.

#### **Local Issues:**

#### Semi – Annual Meeting of the Local Unions (SAMLU)

In early April I was in attendance at the SAMLU which was held in Hollywood Florida. Following the welcome remarks of Local 318 President Nick Mosezar, the attendees observed the ceremonial Installation to Office for National Secretary — Treasurer Tim Dwyer. Additional items on the Agenda included:

The final day of the SAMLU consisted of a training session on the implementation of the 2016 National Agreement. This training was both well prepared and informative.

#### • Legislative Conference

The National Postal Mail Handlers Union conducted its 2017 Legislative Conference on May 8<sup>th</sup> and 9<sup>th</sup> in Washington, DC. In attendance for Local 323 were Recording Secretary Dean Abatte and North Dakota State



Executive Board Member Brock Engstrom. These gentlemen met with their respective Congressional Delegations so that the voice of the Local 323 Membership could be heard on many important Postal Issues.

Following our participation in the Legislative Conference President Trump introduced budget proposals which have the potential to significantly impact Mail Handlers and retirees. In particular, increasing employee retirement contributions, reducing annuities by changing to a "high 5" rather than a "high 3" computation, elimination of the social security supplement for FERS employees who retire before the age of 62, and the elimination of FERS cost of living adjustments as well as the reduction of CSRS cost of living adjustments for current and future retirees. With respect to the Postal Service, the President's budget proposes \$46 billion in cuts over the next decade, reductions in the frequency of mail delivery, and corresponding cuts to mail processing. Suffice it to say that we'll be keeping a close eye on the potential enactment of any of these proposals.

#### Local Elections

On May 15<sup>th</sup> the Judges of Elections held the nomination meeting for the Officer positions that comprise both the Local Executive Board and the Local Union Council. All of the current Officers were nominated and no offices were contested. Accordingly, and following the expiration of the time period allowed for filing protests, the Judges declared all Officers elected by acclamation.

#### • 2017 Local 323 Scholarship

The 2017 Local 323 Scholarship program was announced near the end of May. This program provides for a 4 year \$800.00 annual Scholarship which begins in September of this year. Copies of the rules and applications are available on the Local 323 web site. Opening date for the acceptance of applications is June 1, 2017. The closing date is June 30, 2017.

Any graduating senior who is the son, daughter or legal ward of any regular member in good standing of Local 323 of the National Postal Mail Handlers Union may apply. Good standing is defined by Article V, Section 1, of the Uniform Local Union Constitution of the National Postal Mail Handlers Union. Applicants must file an Official Application with the Local Union Office.

#### **Branch Activities:**

On April 29<sup>th</sup> I was in Fargo, ND, for a meeting of the Fargo Branch. The meeting was, as usual, well attended. Several issues of concern to the Members were addressed and it was good to see level of interest people are taking in their Union.

Since the last report, I've attended several labor – management meetings at the St. Paul P&DC and one at the NDC. In addition, I spent some time in Mankato working on their computer and helping the Steward with a step 3 appeal. I continue working with the Branch Representatives as needed to address specific concerns.
